The Farmers Market will advertise in the local papers, however, you will also need to market yourself to help bring in customers. Use social media, let them know where you are, help bring in customers!

**Set-up:** Fridays starting at 8:00am. No one is allowed to begin set up after 9:30am.

Tall displays (over 4 foot high) must be by a wall, which are limited spaces, or do not set up a tall display. 10x10 spaces can have canopy frame.

You must be able to bring in your boxes, go park your car, then set up; so you are not tying up the loading zone area.

All vendors must set-up on Friday, and **stay until Sunday closing.** No early take-down. Do not come if you cannot be there the entire time.

All vendors must use a **black table cloth** that reaches to the floor on all tables! They are available for purchase for \$25.00.

Displays must be clean, organized and in a manner that is pleasant to look at. Christmas décor is encouraged.

**Take down:** Only bring enough that you can set-up and take-down in an hour. Sunday night, there will only be a 1½ hour limit to take-down when everyone must be out. You must not leave ANY mess behind.

**Storage.** There is no storage. It is up to you to decide to leave your product in a box under your table over night, or cover it, or take it with you. Sunday night, everyone must be totally out.

Management will try not to have the same products at the same time. However, it may happen.

Vendors are responsible for reporting daily sales totals to the Market staff at the end of each day.

Management has the right to refuse any product and/or vendor at any time.
