# FEES FOR 2020

## THE FEES BELOW ARE PER MARKET DAY

**Farm product vendors:** \$40.00 for 10x10 stall plus 6% of daily sales.  
Single space \$40.00 + 6% of sales  
Double space \$80.00 + 6% of sales

All vendors must read and sign a copy of the Rules and Regulations (Available on web site)

**PLEASE SEND IN PAYMENT WITH APPLICATION:** (Choose one option)

Pay for the entire season and get a discount: (based on a single booth)  
(Non-Refundable. Booth fee only, 6% still due each day)  
Pay by March 15th, get 2 free booth price days (PAY 1000.00)  
Pay by March 30th, get 1 free booth price day (PAY \$1040.00)

OR

Send in \$200.00 with application to reserve spot (based on a single booth)  
(Non-Refundable. This amount will be applied to your booth fees)

**Farm products must not be resell items. Must all be grown and harvested by the seller.**

All vendors must read and sign a copy of the Rules and Regulations (Available on web site)

No smoking in or around the premises of the market.

Only one business per booth. Due to pets at market, please keep everything off of ground.

Vendors are responsible for reporting daily sales totals. If you are suspect of not reporting the correct amount, you will be subject to an audit and removal from the market.

Market Management has the right to limit/refuse vendors according to the rules & regulations.
